Buenaflor.

- (b) REGINA R. BUENAFLOR has the power to dispose of 20 Founder shares and 6,780 Common shares.

REGINA R. BUENAFLOR has the power to vote for 20 Founder shares and 6,780 Common shares.

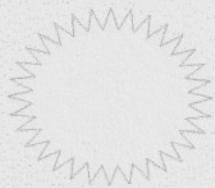
