He is one of the founders of Asia Pacific Medical Center-Aklan Inc. (formerly: Allied Care Experts (ACE) Medical Center - Aklan Inc.), with office address at Judge Martelino Road, Andagao, Kalibo, Aklan and husband of one of its current Directors, Dr. Regina R. Buenaflo. He is a practicing Pulmonologist in the following Hospitals: St. Gabriel Medical Center, St. Jude Hospital, Aklan Cooperative Mission Hospital, Panay Healthcare Multipurpose Cooperative Hospital and Dr. Rafael S. Tumbokon Memorial Hospital.

PATRICK DEXTER M. BUENAFLORE is a beneficial owner of an aggregate of 17,000 shares comprised of 50 founder shares and 16,950 common shares representing Seven point ninety-four percent (7.94%) of the outstanding shares of the Registrant, 10,200 shares of which by direct ownership and 6,800 by indirect ownership through the 6,800 shares owned by his wife Regina R. Buenaflore.

- (b) PATRICK DEXTER M. BUENAFLORE has the power to dispose of 30 Founder shares and 10,170 Common shares.

PATRICK DEXTER M. BUENAFLORE has the power to vote for 30 Founder shares and 10,170 Common shares.

The shares of the reporting person were increased to the number in par. a because he acquired 20 Founder shares and 6,780 Common shares of Dr. Michael Edward R. Enriquez through a Deed of Assignment executed on October 15, 2020.

The BIR CAR for the transfer of shares of Dr. Michael Edward R. Enriquez was received by the Assignee on March 2023. See attached Annex A for more details.
