#### PROJECT MANAGER'S SUMMARY

Major work activities on-site are Architectural, Plumbing, Fire Protection, Electrical, Electronics, Mechanical Works respectively, OSM and other items are all on its installation phase and some areas are already subject for punch listings specially from Ground Floor to 4<sup>th</sup> Floor and areas at 7<sup>th</sup> Floor including Auditorium and Kitchen/Canteen.

As of December 31, 2023, Structural Works is at 100%, Architectural Works and Interior Fit out at 81.36%, Plumbing Works at 90.67%, Fire Protection Works is at 89.87%, Electrical Works is at 92.50%, Electronics Works Roughins at 99%, Electronics Works Devices at 86.28%, Mechanical Works at 97.72%, Perimeter Fence & Road Networks at 100%, Site Development Auxiliary Structures is at 100%, Medical Gases at 70.13%, Elevator & Escalator at 97.06% and Owner Supplied Materials at 85% delivered and installed.

With 94.19% over all completion percentage based on the re-aligned budget of the original contract.

Additional works are prioritized for the month of December 2023. This works are Majority for 5<sup>th</sup> and 6<sup>th</sup> floor. The breakdown as Follows Architectural Works and Interior Fit out at 60.35, Plumbing Works at 51.55%, Fire Protection Works is at 64.37%, Electrical Works is at 47.67%, , Electronics Works Devices at 0.00%, Mechanical Works at 38.07 and Glass and Aluminum at 81.90%. A total accomplishment for additional works of 47.01%

The Structural Works project has been finished and completed by March 2022. On January 4, 2021, contractors for Plumbing Works, Fire Pro Works, and Electrical Works were brought on board. These companies' names are 24" Gauge Construction Inc. and RMT Electrical Works, respectively. In November of 2021, the Electronic Works contractor, Synchronized Solutions Inc., began mobilizing their workforce on-site. Mechanical contractor JRDM Builders Corp On-boarding was in November of 2021. OSMs have arrived onsite and installed and is expected to contribute in the project progress.

External issues such as the pandemic and typhoons ——resulted in delays in the completion of the project, which drew out the timeline for its completion. Additionally, stringent health rules that have been adopted by the LGU of Aklan are a factor in the progression of the project because of the impact they have on logistics and the workforce. The construction at the site is making steady progress, and in order to mitigate risks, the schedules have been reorganized.

#### **PROJECT STATUS**

#### A. Program Summary

The project has three-year construction duration, counting Day 01 from **November 22, 2019, to March 2023.** To date, it has been running on its 49th month or 196th week since Day 01.

The Civil & Structural Works for the Main Building is now substantially complete at 100%.

**Architectural Works**, which were granted and on boarded on March 21, 2022, is now contributing an accomplishment gain of **81.36%**. Other trades are now closely coordinated with architectural works as the work onsite progresses. Punch listings are now conducting on areas from Ground to 4<sup>th</sup> Floor and areas at 7<sup>th</sup> Floor.

The **Plumbing Works** Contractor on-boarded on-site on January 4, 2021, and originally scheduled to complete their work on December of 2022. However, with the delay of Structural works and strict health restrictions imposed by LGU. As of to date they have **90.67%** completion on their work scope. Water source connection from local water has already entered the building. Plumbing fixtures are already installed.

On January 4, 2021, the **Fire Protection Works** Contractor started working at the site. The Fire Protection works are currently at **89.87%** complete. Pumps are already installed subject for final testing. Fire Hose cabinets are also installed and other appurtenances.

The **Electrical Contractor** on-boarded on-site on January 4, 2021. Their completion is reset and currently on realignment due to delayed completion of structural. With challenges faced on-site they garnered a Progress completion of **92.03%** as of to date. The whole building is energized since last month. Lighting fixtures and devices are 40% installed.

The **Electronics & Auxiliary** Contractor was awarded last August 2021 and roughing ins of FDAS horizontal installations of cable trays, CCTV, Voice & Data Piping, Nurse Call & BGM bringing combined progress of **99% for Contract 1-Rough-ins and 86.28% for Contract 2-Devices** completion for the Electrical & Electronics works rough-ins.

The **Mechanical** contractor with completion of **97.72%** as of report. With the arrival of OSMs, the Mechanical works has highly increased in terms of progress, areas from Basement to 4<sup>th</sup> Floor are now on its ongoing testing and power up.

Perimeter Fence & Road Networks is 100% completed as of September 30, 2022.

**Site Development Auxiliary Structures** has an accumulative percentage of **100%**, it comprises of several support structures including Powerhouse, Warehouse, TB Dots, Animal Bite Center, Motor pool & MRF, including the additional Building for CT SCAN and STP Structure.

**Medical Gas** was awarded to New Prime Gas Inc. and has completed **70.13%** of their work package. Arrival of stainless bedhead panels are scheduled before end of month and subject for installation at patient rooms and assigned areas.

Glass Works is 96.02 % as of to date. They are currently prioritizing building exterior for water tightness.

**Elevator and Escalator** is **75%** complete. They are almost complete of the installation as per contract however percentage update is put onhold due to damaged parts for replacement identified during the testing and commissioning.

Owner Supplied Materials (OSMs) are now starting to be delivered onsite with an overall percentage of 90.00% installed items. Major OSM are Gen Sets, Electrical Equipment, ACU, Plumbing Fixtures, Lighting Fixtures and Doors.

#### PROJECT DELAY INFORMATION

The completion of the project was dragged by external factors such as the pandemic and typhoons experienced last year resulting to delays. In consideration to unexpected circumstances brought by the following:

- COVID 19 situation. Also, NCR+ bubble ECQ from March 29 to April 4, 2021 is factoring on project progress as it affects logistics. Site work is continuously progressing and catching up with the schedule.
- Super typhoons that hit the area on December 2020.
- Strict Health Protocols Implementation of Local Government affected project work hours, hiring process and logistics.
- Heavy Rain has flooded the construction site last October 23, 2021. This brought work into halt as the area needs to be dewatered and areas for work is not accessible.

The project has to adjust its completion as the area was increased adding additional work scope in the total projects. These are as follow:

- An additional area on 5th and 6th floor with a total of 1,160.26 sq. mts was approved. Budgeted at an additional of Php 12,157,345.64. This is not part of the current original contract of the contractor. Thus, work onsite has to extend until January of 2022.
- Another additional area was just approved by the APMC board last October 23, 2021 amounting to Php 2,803,926.61, with this new additional area to be added to the contractor scope of work an additional of 3 months is needed to cover such work. The contractor is confident to complete this additional work by January 28 of 2022 as the new Completion Date Schedule
